# Rules, Regulations and Conditions of Membership

## Article One: House Rules

If accepted for membership, I agree that such membership at all times shall be subject to the By-laws of Green Hill Yacht and Country Club, Inc. If my application is accepted and approved by the Board of Directors, I agree to pay in full the membership dues per member classification as it becomes due and any rental and/or activity fees.

I understand and agree to comply with the By-laws and General Rules of Green Hill Yacht and Country Club, Inc., and that those documents are amended from time to time. I understand and agree that if I do not abide by these rules and bylaws (a copy of which I will be furnished upon approval of membership), the Board of Directors may issue a suspension or termination of membership.

I understand that Green Hill Yacht and Country Club, Inc., is not responsible or liable for any loss, theft, damage or injury to property or persons of members and guests. All members and guests use the club facilities at their own risk.

I understand that The Management and The Board of Directors reserves the right to make necessary changes to all rules, regulations, bylaws, dues, etc. of Green Hill Yacht and Country Club, Inc., from time to time at their discretion.

## Article Two: Membership

I understand that I must be at least eighteen (18) years of age to apply for and be eligible for membership at Green Hill Yacht and Country Club, Inc.

I understand that if I am applying for a Full Equity Membership and I am approved that I must pay the \$2800.00 one-time equity fee. I understand that this membership category entitles me to full voting rights and one (1) share of stock in the Green Hill Land Company. I understand that if this membership category has a full complement of members, each person approved for such membership category shall take his place at the bottom of the waiting list for this category of membership.

I understand that if I am applying for the Young Executive Program that I or my spouse (the eldest of the two) must be younger than thirty-five (35) years of age.

## Article Three: Termination of Membership

I agree that if I terminate or the Club terminates my membership within 12 (twelve) months of the approval date, I will pay one hundred-percent (100%) of dues remaining on the initial 12-month membership agreement.

I understand and agree that in the event of my resignation, I am ineligible to apply for reinstatement to Green Hill Yacht and Country Club for a period of twelve (12) months from the date of my resignation notice and approval.

I understand that dues may not be tax deductible under the law per IRS code.

I understand and agree that by providing my signature, this is a binding contract between myself and Green Hill Yacht and Country Club, Inc. I agree to abide by this contract and if I do not, I am in breach of contract with Green Hill Yacht and Country Club, Inc.

I agree that a letter of resignation is required and must be approved and signed by the Board of Directors to terminate this binding contract.
